## **What We're About...**

The Perry County Fraternal Order of Police is offering young people an exciting, up-close look at law enforcement, the criminal justice system, and all other emergency services through its 13<sup>th</sup> annual youth camp. This camp will help students gain respect for themselves and others through programs that demonstrate the rewards of hard work and dedication.

1. This program utilizes educational and recreational activities to create trust and understanding between police officers and youth. It is based on the conviction that young people - if they are reached early enough - can develop strong positive attitudes towards police officers in their journey through life toward the goal of maturity and good citizenship.
2. The Perry County Fraternal Order of Police Youth Camp "Camp with a Cop" brings youth under the supervision and positive influence of law enforcement and expands their awareness about the role of a police officer and the reinforcement of the responsible values and attitudes instilled in young people by their parents. Such respect is beneficial to the youth, the police officer, the neighborhood and the community.
3. The Perry County Fraternal Order of Police Youth Camp "Camp with a Cop" strives to connect our youth and law enforcement and the criminal justice system in a positive way with character building tools to deter juvenile crime and violence; as well as, create interest in possibly getting involved law enforcement later in life. The friendship and trust built through this structured camp will help teach our youth that they have a friend behind the badge. These bonds can last a lifetime.

This **four-day/three-night camp, beginning Tuesday July 16<sup>h</sup> @ Noon, Wednesday July 17<sup>th</sup> Thursday July 18<sup>th</sup> & Friday July 19<sup>th</sup>, is for students entering 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup> grades.**

There are no residency requirements and our camp is open to kids from anywhere. Campers will arrive on Tuesday afternoon and graduate on Friday evening. The Camp drop off location is Tell City High School (Tell Street Parking Lot) at noon on Tuesday July 18<sup>th</sup>. The campers will arrive and place all belongings and property into a designated area. The camper will then proceed to the school cafeteria where they will register and receive photo ID's. At this point, Camp staff will collect all medications and medical orders completed by parents or guardians. Once registration is complete, campers will go swimming in the TCHS pool and will be served pizza. Once the registration process and swimming time is complete, campers will be transported by bus to the Glennwood Camp Facility.

***CAMPERS WILL WANT TO WEAR SWIM SUITS/TRUNKS UNDER THEIR CLOTHING WHEN THEY ARRIVE FOR REGISTRATION.***

The camp itself will be conducted at the Glenn Woods Hills Camp & Retreat located at 10848 Tide Road, Derby, IN. 48525-9698.

Directions to the camp are located below. Graduation celebration will be held at the Campground on **Friday at 4:00 p.m.** Campers will be released to go home after graduation. Bus service **will not** available on Friday.

***\*\*\* We encourage parents or family members to not attend during camp. This is only due to the fast pace schedule of events and liability on the camp grounds. If a parent or family member visits camp, they will only be permitted in the Chapel Classroom. Parents are however able to apply for volunteer services by completing an application prior to camp dates. It has been staff member's experience due to the fast pace of the camp, parents of children with special needs, severe medical issues, or children who do not like physical activity, may want to reconsider if this camp is right for them. As this camp consist of outdoor physical activities from sun up to sun down daily. This includes high heat conditions, rain, and other inclimate weather.

Camp staff members are handpicked, responsible law enforcement personnel from every agency in the county and surrounding agencies, who have committed themselves to preparing today's youth for their futures. Additionally, campers receive one on one time with law enforcement officers, who help them develop relationships that will last a lifetime.

Camps are made possible through the support of the local area businesses, the Perry County Substance Abuse Committee, the Perry County Fraternal Order of Police, the Cannelton Police Department, Tell City Police, Perry County Sheriff's Office and citizens like you, willing to sponsor a child.

The cost is **\$60.00** per camper and sponsorships are available for those financially challenged. To apply for sponsorship funds YOU MUST include a one page letter, in your own NEAT handwriting, explaining why you would like to be awarded a sponsorship. ***This sponsorship request must be turned in by June 24, 2019. No Sponsorships will be offered beyond that date!!!***

## **FOR PARENTS**

### **Opening Day**

Opening Day is an exciting time for everyone! Campers should wear swim suits under their clothing at the arrival of day 1. **Campers should bring all needed items from home with them to the Tell City High School Cafeteria.** When you arrive, a staff member will greet you and your camper(s) and you can complete your check in. The campers will arrive and place all belongings and property into a designated area. The camper will then proceed to the school cafeteria where they will register and receive photo ID's. At this point, Camp staff will collect all medications and medical orders completed by parents or guardians. Once registration is complete, campers will go swimming in the TCHS pool for swimming and other aquatics activities. Once the registration process and swimming time is complete, campers will have a pizza party before being transported by bus to the Glennwood Camp Facility.

If a parent or someone other than a parent or guardian will be picking up a child early from camp for any reason, they must inform the camp staff at registration. This policy is designed for the protection of all of our campers. Once we arrive at camp, we will unpack. Snacks will be provided to campers. Campers will spend the night in our **air conditioned** dorms that evening. Bunk beds will be provided, however you will want to bring **a sleeping bag or bedding and pillow.** The next morning, campers will have a good breakfast and have a fun-filled day ahead.

### **Graduation (4th) Day**

**Beginning at 4:00 p.m. campers will have a graduation ceremony.** Parents are encouraged to attend and may begin to arrive no later than 3:30 p.m. We will have signs along the way to help you get to the camp. Signs will also show you where to park, upon your arrival. The ceremony will be held at the Pavilion, on camp property. As soon as graduation is over, the camp will conclude.

Please fill out the pages labeled as A and B, and place the registration fee (check only please, no cash) in an envelope. **IF YOUR CHILD TAKES MEDICATION AND NEEDS TO HAVE THE MEDICATION ADMINISTERED, YOU MUST FILL OUT AND RETURN THE VERY LAST PAGE.** You can either mail it to the department or drop it off. 

### **Personal Conduct Rules**

1. Absolutely No Electronic Devices!! Campers may bring a cell phone, but that cell phone will be secured in a lock box with staff during camp and only utilized in emergencies. Any electronic device used for medical reasons may be considered by staff.
2. Senior Camp Staff has the right to send campers home for misconduct without warning. Parents will be contacted and responsible for picking the camper up in a timely manner. Campers sent home for misconduct will not be reimbursed camp fees.
3. Show respect to everyone (fellow campers, special guests, staff, junior staff, kitchen staff)
4. No Foul language, bullying, or fighting!! This is zero tolerance!!
5. Out of Bounds, wondering off from the squad or camp activities
6. Buddy System – Anytime a camper travels away from their squad for various reasons (bathroom, water break, change clothing, ect) He or she must have a buddy travel with them and must get permission from Squad Leader or other officer in charge.
7. No waterfront without a lifeguard present (Lifeguard is always in charge while at the water)
8. No boats, kayaks, canoes without a life jacket on
9. No males in female dorms, no females in male dorms
10. No entering dorms without staff permission expect for designated shower and sleep times
11. Raise your hand when you have a question
12. Hydrate, remember your water bottles (Gatorade and water everywhere we go)
13. Dining hall etiquette and manners (hands cleaned, stand in line, KP duty)
14. Showers every night without exceptions
15. Lights out time is 10:00 pm, you are not to leave the dorms after 10:00 pm without permission (night watch staff)
16. ID / Name tags will be worn at all times, hang on the hook at waterfront for tracking when in water
17. If you have questions or problems, contact your squad leader or staff member
18. No horseplay (here to learn and have fun but the camp staff will have zero tolerance for bullying and roughhousing)
19. Junior staff are here to help and will be respected
20. If you forgot to bring something, let us know, we will help you get it.
21. Most importantly; have fun, smile, laugh, and learn!!
